## USMLE to Transition to Limited Testing Dates Each Year Starting in 2028

The United States Medical Licensing Examination® (USMLE®) program will reduce the number of Step exam administrations each year beginning in 2028. This exam administration model, which the USMLE program calls Designated Testing Dates, is designed to further strengthen exam security, uphold the integrity of the assessments and support fairness.

With this transition, the three USMLE Step exams will together be offered over a total of 45 days. These dates were selected through rigorous analysis of historical testing patterns in the U.S. and globally for each Step exam, along with consideration of medical education and licensure milestones.

Please note that the number of testing dates will most likely not change, but individual dates on this calendar may be updated. We will share any changes as soon as they are available.
